### McClallen Soccer Field Rental Fees

Morton Park District Programs & Affiliate Groups......\$ 0/hr./field

All other groups.....\$100/hr./field

\$150/hr./field (Lighted)

Discounted field rental rates available for multiple day rentals.

Field rentals are subject to availability based on the following priority schedule:

- 1. Morton Park District Programs and Activities
- 2. District 709 Teams Games & Practices
- 3. Morton Park District Approved Youth Affiliate Groups
- 4. Private Rentals
  - <u>Teams are responsible to set up and take down their own corner flags</u>. (Flags are in the large box outside the garage door of the concession building.)
  - The last group leaving the park is required to ensure that all field lights have been turned off.
  - **No dogs (or other pets)** allowed at McClallen Park. (It is the responsibility of the renter to inform anyone in attendance with a dog (or other pet) that they must remove the dog/pet from the park)
  - No parking in the grass. All cars must use the paved parking lot.
  - **No smoking** is permitted.
  - The person in charge is responsible for ensuring that all goal stakes are properly in place prior to the start of each practice/game.
  - Under no circumstances may any goal be moved by a renter.
  - Ongoing rental users will be responsible for replacing net zip ties as needed.
  - Any renter who charges a fee for participation will be required to provide MPD staff with a current certificate of general liability insurance naming the Morto Park District as "additionally insured."
  - The person in charge will be responsible for the supervision of their participants and for leaving the facility in an acceptable condition. All trash must be disposed of in trash cans provided at the facility. At the end of the event, all trash must be placed into the dumpster.
  - The Morton Park District recommends that any renter require two background checked adults to be present at any practice, game, tournament, or official activity of the renter.
  - Renters are not allowed to sub-rent fields to other individuals, teams, or organizations at any time.
  - All sponsorship signage or advertisement is required to be approved by the Executive Director before being placed at McClallen Park. The Executive Director will have 1-week for approval/non-approval.
  - When weather or usage impacts facility availability at the Park District's discretion, private field rentals
    may be canceled with or without prior notification. Availability will be based on Park District, District 709
    and Affiliate Group needs.

# ASSUMPTION OF RISK AND WAIVER OF LIABILITY AND PARK DISTRICT RENTAL GROUP RELEASE

#### ORGANIZATIONAL RENTAL PARTICIPATION WAIVER

I understand and agree that this assumption of risk, waiver and release includes and covers, but is not limited to, any Claims of myself and the participant(s) based on the actions, omissions, or negligence of the Park District, its Commissioners, employees, agents, contractors, insurers, attorneys and/or representatives.

In consideration for the participation of the participant(s) in the Park District program(s) set forth below and entry into and use of Morton Recreation Center, Freedom Hall, Barn at Bull Run and any other Park District park(s) and/or facilities, I acknowledge and voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself and/or the participant(s), on behalf of myself and the participant(s), including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that I and/or the participant(s) may experience or incur in connection with my or the participant(s)'s attendance of and/or participation in Park District programs and/or use of Park District facilities, specifically including, but not limited to, the Park District program set forth below and the use of the Morton Recreation Center, Freedom Hall, Barn at Bull Run and/or any other Park District park(s) and/or facilities therefor.
